

The Board of Fire Commissioners, Gloucester Township Fire District # 4 held a Workshop Meeting on February 1, 2023. The meeting was held at Blackwood Fire Company, 14 W. Central Avenue, Blackwood NJ 08012. This meeting has been properly advertised according to the State of New Jersey Sunshine Laws.

COMMISSIONERS: D. Vannoni, M. Cristella, M. Jones, J. Vannoni

Commissioner J. Vannoni reported the following:

1. Sent the apparatus camera policy to everyone for review. The policy should be adopted by District # 2 tomorrow night, at their meeting. He will bring it up at our Regular Meeting on, 2/15 for adoption.
2. He is requesting closed session to discuss a Personnel issue.
3. District #2 is in the process of replacing K. Young's position. He said he will be involved in that.
4. Engine 82 was involved in an accident. They will use reserve Engine 88 when Engine 82 goes out for repair.

Commissioner Jones reported that from the pictures he received, the damage seemed minor.

Commissioner Jones reported the following:

1. The Tower Ladder's second opinion testing will be done on 2/9/23 at Blackwood Clementon Road.
2. Engine 84 highest bid is \$2500.00

Commissioner D. Vannoni asked why it will not start?

Commissioner Jones replied it was the fuel, he believes.

3. The hose that was ordered in August will arrive shortly. When questioned by Commissioner Cristella about all the hose we currently have, Commissioner Jones replied this was ordered prior to the 2 pieces of apparatus going out of service.

Commissioner Cristella reported the following:

1. The roof at Blackwood Clementon Road is repaired.
2. He will be looking into getting a large storage container for Blackwood Clementon Road, following the Election, and approval of the 2023 budget.  
He went on to say that Blackwood Fire Company can get one, but the funds would come out of the Station # 1 building funds.

Commissioner D. Vannoni reported the following:

1. Life Hazards certified report has been signed and sent to the State.
2. Issues with the internet at Blackwood Clementon Road are being handled by Clarity Technology.

No comments from the floor.

Motion by Commissioner Cristella, second by Commissioner Jones to pass resolution to go into closed session to discuss Personnel. All in favor, motion carries.
